CCP MOU's Partner Discussion:

The coalition members discuss how our MOU's can help the CCP Coalition. First MOU's discussed was the schools and they can bring in awareness, student involvement, bring other agencies within the school partnership, and promoting the coalition around campuses. Second was the Law Enforcement and they can bring in enforcement, education, and an outlet to what they see. Third was youth and they bring knowledge of what is going around in the community, experience with certain drugs and how they get it, and Point of View. Forth was Faith and they can bring in resources for the coalition, point of view, support system from the church, and volunteers. Fifth was other coalitions and they can bring stronger partnerships and maximize our efforts around the community. Sixth was youth education and they can bring in prevention ideas to the coalition and Point of view. Underage drinking:

Donine discuss about placing the stickers on police cars that say "Seats Reserved" and so far Port Aransas, Constables, Bishop, Portland, and Corpus Christi

have agreed to place them on their cars. During the PowerPoint the coalition discuss about contacting the Condos in Port Aransas and maybe trying to inform them that underage drinking could possibly happen without them knowing. Tiffany from Wellness Foundation talked about Port Aransas City Council are having an ordinance place by January that no alcohol beverages will be prohibited after 6:00pm. They want to let people know two months in advance for any spring breakers that this ordinance will take effect. Tiffany Montemayor brought up to the coalition about the Ingleside Students Against Destructive Decisions (SADD) is a group that we should get in contact with. SADD always has events around or during spring break to bring awareness to the people on the beaches. The coalition also discuss about the social hosting.

Prescription Drugs:

During the PowerPoint the coalition discuss about the Prescription Drug Naloxone also known as Narcan. Linda informed the coalition about the Prescription Drug and how it works. She also stated that a bill was authorize for emergency services personnel to administer an opioid antagonist to a person who appeared to be suffering an opioid-related drug overdose, as clinically indicated.

Marijuana:

During the PowerPoint the coalition discuss about the effects of K2/Spice. The coalition thought about how to educate the community and will media campaigns will work. The coalition discuss what was in K2 and the different names for it. K2 is becoming popular amongst the homeless population and how can we as a coalition educate the homeless about K2.
